Hi Ryan,

We do work with NP and PA's that could help. Depending on the needs and locations would vary how many providers we can deploy. Also if they have to have a NH license or if any active, unrestricted license will work will affect how many providers we can use.

The rate for local providers (NP/PAs) without travel would be \$75/hr. The rate for providers that require travel (NP/PAs) with travel/housing would be \$90/hr.
