How to Certify Confirmed and Suspected COVID-19 Deaths

As the Office of the Chief Medical Examiner (OCME) has statutory jurisdiction over all deaths related to a disease which might constitute a threat to public health, all suspected and confirmed COVID-19 cases should be reported to the OCME (860-679-3980). The vast majority of these decedents, however, will not be brought to or certified by the OCME. As these are natural deaths, death certification should be completed by the treating physician. The degree of certainty needed to certify a natural death is a medical probability (that is, more likely than not).

Deaths primarily due to COVID-19 with a confirmed test, should be certified as:

Complications of novel coronavirus (COVID-19) respiratory infection

Part 2 may be used for contributing conditions such as: Pulmonary Emphysema, Asthma, Obesity, etc.

Deaths <u>suspected</u> to be due to COVID-19 with <u>testing pending</u>, should be certified as:

Complications of respiratory infection (suspect COVID-19)

Part 2 may be used for contributing conditions such as: Pulmonary Emphysema, Asthma, Obesity, etc.

Deaths <u>primarily related to cardiac, liver, kidney, pulmonary disease, etc.</u>, in which a recent respiratory infection may have been enough of a stressor to contribute to death, may be certified with the primary disease in Part 1 and the respiratory infection in Part 2.

For example:

Congestive heart failure due to atherosclerotic cardiovascular disease Part 2: Recent novel coronavirus (COVID-19) respiratory infection

For patients who die in the ED with a history of a current respiratory infection but no prior COVID-19 testing, postmortem swabs should be obtained in the ED for testing.
