
SUBJECT: Federal Pharmacy Partnership in Connecticut

As a jurisdiction, Connecticut has decided to participate in the Center for Disease Control and Prevention's (CDC) Pharmacy Partnership for Long Term Care (LTC). This program will offer vaccines to the residents and staff of all long-term care facilities int the State of Connecticut through on-site clinics that are run by CVS and Walgreens.

The Pharmacy Partnership for LTC Program provides end-to-end management of the COVID-19 vaccination process, including cold chain management, on-site vaccinations, and fulfillment of reporting requirements, to facilitate safe vaccination of this patient population, while reducing burden on LTC facilities and jurisdictional health departments.

In the coming weeks, the locations listed on the attached sheet should expect to be contacted directly by CVS or Walgreens with further instructions\*. Skilled nursing facilities will be vaccinated in the first part of the program, with assisted living facilities to follow. On site vaccination in skilled nursing facilities is expected to begin as early as the week of December 21st in some locations. Both residents and all staff are eligible to be vaccinated through this program.
